## Question:

For each of the facilities identified in response to DOC No. 34 in which a utility obtains the energy under a power purchase agreement (PPA), please identify who owns the green tags or environmental attributes for the renewable energy being generated.

## Response:

Great River Energy, Missouri River Energy Services, Minnesota Power, Dairyland Power Company and Rochester Public Utilities own all of the green tags and/or Renewable Energy Credits ("RECs") from all of the PPA facilities identified in response to Department of Commerce Information Request No. 34. Information about Minnkota Power Cooperative was not included in response to Request to No. 34, but its PPA with Langdon was included in response to Department of Commerce Information Request No. 39, and Minnkota owns the RECs associated with this PPA.

Xcel Energy owns the RECs or green tags associated with the renewable energy generated from all of the PPA facilities identified in Department of Commerce Information Request No. 34. Xcel Energy recognizes that some of its older renewable PPAs are not explicit in separating REC ownership from ownership of renewable energy generated by those facilities. In the M-RETS Dockets (MPUC Docket Nos. E-999/CI-04-1616 and E-999/CI-03-869), the Commission ordered Xcel Energy to work with the contract vendors in these so-called "silent contracts" and determine whether any of those vendors have a different opinion about Xcel Energy's right to claim entitlement to the RECs. Xcel Energy's investigation into this issue is ongoing. Per the Commission's Order, Xcel Energy will report to the Commission the outcome of its investigation on March 1, 2008.

Southern Minnesota Municipal Association has one PPA for the Big Blue Wind Farm that will be operational in late 2009. The company will own all of environmental attributes which will be tracked via the Midwest Renewable Energy Tracking System ("M-RETS").

Central Minnesota Municipal Power Agency and Otter Tail Power Company own all of the attributes for the resources shown in the response to Department of Commerce Information Request No. 34 with the exception of those facilities listed on the attached Excel spreadsheet.
