## CHRISTOPHER T. ELLISON

### **PROFESSIONAL:**

Successfully petitioned the California Public Utilities Commission to change its line extension policies to remove disincentives, and alternatively provide incentives for energy conservation. Lead staff attorney in the U.S. Nuclear Regulatory Commission inquiry into the safety of the Rancho Seco nuclear power plant after the accident at Three Mile Island. Briefed and argued the successful appeal of a Superior Court ruling setting aside Commission regulations affecting all new homes.
