### Attending the Meeting

- Public comment will be taken in the order in which registration was received.
- Each person will have three to five minutes to speak.
- Persons who wish to speak are encouraged to provide summary positions on the facts in the case record.
- Please note that all comments from previous public hearings are in the official record, presented on pages 102 through 158 of the Report of the Administrative Law Judge, and reviewed by the PUC Commissioners prior to this meeting. Because the hearing record is closed, no new evidence can be accepted. However, commenters may provide written documentation that supports summary positions. Nine (9) courtesy copies of any written submissions are encouraged but not required.

# Oral Argument

Oral argument before the Commission by formal parties is conducted pursuant to Minnesota. Rule 7829.2700. Parties will be heard in the following order and within the allotted time. Answers to Commission questions will not reduce the allotted time. The Applicants will be allowed a final rebuttal.

20 minutes Applicants Great River Energy/Xcel Energy

10 minutes Robert and Patricia Johnson

10 minutes NoCapX2020/United Citizens Action Network

10 minutes Applicants' Final Rebuttal

Oral argument will begin after public comments have been heard, beginning not later than 1:30 PM and continuing that day until complete. Upon conclusion of oral arguments, the official record is considered closed.

Commission deliberation on this matter is scheduled for Thursday, July 15 at 9:30 AM, following preliminary matters, and is open to all persons. However, no additional testimony will be taken except as direct and limited response to a specific question from Commissioners to parties.

In addition to the Findings of Fact, Conclusion and Recommendation of the Administrative Law Judge, issued on April 30, 2010, Commission briefing papers have been prepared by the Office of Energy Security.
