**NOTICE OF PREHEARING
CONFERENCE**

This matter was remanded to Administrative Law Judge Richard C. Luis of the Office of Administrative Hearings by the Minnesota Public Utilities Commission on July 27, 2010. The Commission directed that the ALJ reconvene the hearing for consideration of additional evidence regarding the Minnesota River crossing by the proposed High Voltage Transmission Line to run from Brookings, South Dakota to Hampton, Minnesota, in particular whether it is preferable to cross the Minnesota River at Belle Plaine or at Le Sueur and which crossover route is preferable (if a crossing at Belle Plaine is preferred).

Pursuant to the Commission's direction, a Prehearing Conference will be held on **August 16, 2010** at 2:30 p.m. in the Large Hearing Room at the Public Utilities Commission, 121 Seventh Place East, Suite 350, St. Paul, Minnesota 55101-2147. Persons participating in the Prehearing Conference should be prepared to address the question of how best to proceed on remand and discuss time frames, scheduling, and procedures for soliciting and receiving public comment on the remanded issues.
