- I, (Dan Flotterud for St Paul's Evangelical Lutheran Church and School), states and deposes as follows:
 - 1. My name is Dan Flotterud President of St Paul's Evangelical Lutheran Church and School own property at 30289 59th Avenue Way, Cannon Falls, Minnesota, 55009 in Stanton Township.
 - 2. Our School and Church are potentially affected by the CapX 2020 Hampton-Rochester-La Crosse transmission line. The School has been at this location for over 30 years.
 - 3. The line is to follow our West property line and depending on the pole locations may affect our athletic fields and limit future development of the 75' west edge of our property. It would also be on the west edge of a lot we own and have had for sale and would make the west 75' of the lot unbuildable and undesirable for many potential buyers. No one has contacted me about compensating us for the losses and limitations

on the future use of the property. Some parents are concerned about their children playing soccer or softball under or close to such a powerful power line. In addition to our own school the local soccer club and high school soccer club team use the field next to the power line route.

- I did not receive any notice whatsoevercer of the very late addition of a potential route that affected my property before the public hearing. I know of no one else at our Church or School who got notice of this route we thought the route next to Hwy 52 was out and it would be at least ½ mile West of our Church and School.
- I first learned of this route change on when a member Dick Bushian who attended the meeting passed on the information and the rest of the details when it was printed in the Cannon Falls Beacon newspaper.
- 6. Former President Dick Bushian went to a Public Hearing in Cannon Falls and gave our comments there at the public hearing, stating that we had a school with students on the site 6 days a week and we would prefer the route farther West..
- 7. I did not intervene in this docket at the time, I did not know what intervention meant, did not know it was an option, and did not think that a route proposed so late could be chosen by the Public Utilities Commission since no environmental impact study was done on this route. I am learning about this process and participating as best I am able at this time.
